Pā Gerard said he felt the boys are exposed to a really good range of activates and opportunities. Impressive as school is so physically isolated.

Discussion around PLD and engagement 2024 document – Pā Nathan said intended to give a feel of what is going on.

Kelly moved Principal's report be accepted, Pā Gerard seconded.
